# INVITATION for EXPRESSIONS of INTEREST

The British Virgin Islands Financial Services Commission (the **Commission**) invites Expressions of Interest (**EoI**) for **Construction Services.** 

#### **SCOPE OF WORK:**

To provide construction works in line with architectural drawings construction working plans. The Construction Services will include modifications, structural electrical, plumbing, and HVAC systems, building finishes, demolition (removal sheetrock walls and fixtures). construction and the disposal of furnishings, fixtures, and construction and other building materials.

#### PROCUREMENT PROCESS:

The procurement process will be conducted in two stages: (1) a prequalification stage involving this invitation for Expressions of Interest, and (2) a request for proposals stage.

## (1) Pre-qualification

Persons are required to submit the Eol Application Form and request a copy of the Invitation of Expressions of Interest.

Upon receipt of the Eol, persons should submit their response as part of the prequalification process.

Individuals will then be shortlisted for an opportunity to tender a proposal to complete the Services.

#### (2) Request for Proposals

If successfully shortlisted, pre-qualified persons will receive a request for proposals document and will be required to submit technical and financial proposals.

One successful consultant will be selected and invited to negotiate a contract.

# SUBMISSION OF EXPRESSIONS OF INTEREST APPLICATION FORM:

The Form <u>must</u> be submitted in electronic format to <u>procurefsc@bvifsc.vg</u> with the subject line <u>"EXPRESSIONS OF INTEREST FOR CONSTRUCTION SERVICES"</u>, no later than 4:30 p.m. on Friday, 2<sup>nd</sup> August 2024.

Persons will receive the EoI no later than 9th August 2024.

### **OTHER CONDITIONS:**

Nothing in the Eol or any communication made by the Commission or its representatives, agents, employees or advisers shall constitute an offer of a contract or a binding contract between the Commission and any applicant, nor shall they be taken as constituting any representation that rights or licences will be granted in accordance with the Eol.

The Commission reserves the right at any time during the prequalification process to change any aspect of the EoI, or to issue an amended EoI.

Applicants acknowledge that the Commission reserves the right to organise the Services independently without officially appointing any third party or may suspend or cancel the pre-qualification and tender

process or the project without assigning any reasons and without prejudice to its right to re-tender at any time in the future. No person shall have any claim arising from the foregoing actions.

Each Applicant is responsible for all costs, expenses and liabilities incurred in the preparation of its Eol, and any responses to requests for further information by the Commission.

Applicants irrevocably and unconditionally waive any rights they may have to bring a claim in any court of competent jurisdiction in relation to the qualification or manner of qualification of any applicant, the selection process or otherwise in relation to the proposal or the EoI. The Commission will in no way be responsible or liable for any detriment suffered as a result of the foregoing, regardless of the conduct or outcome of the EoI process.

Participation by any party in this Eol process pursuant to the invitation by the Commission shall be considered to be an acceptance of all conditions of the invitation by such party, and no claims or disputes raised by it during or subsequent to the award process shall be entertained by the Commission.
